**Ansley Faith Gollihugh Assistance Grant (Ansley Fund)**  
**"Texas State Council Relief Fund"**

**Purpose:**

The Ansley Faith Gollihugh Assistance Grant, hereafter referred to as the Ansley Fund, is designated as a 501(c)(3) qualifying fund used specifically to aid Texas State Council members during unforeseen adverse events, personal tragedy, or hardship circumstance. Donations to this fund will qualify as individual tax-exempt deductions for income tax purposes.

**Eligibility:**

Applicants must be a Texas ENA member, in good standing, with a documented unforeseen adverse event, personal tragedy or hardship circumstance that is brought to the attention of any Texas ENA member.

**Process:**

1. A request for assistance form (attached to this addendum) will be submitted by the member or on behalf of the member who is applying for the hardship circumstances to the Texas State Council President for consideration. The Board of Directors have up to 7 business days to formulate a response and inform the applicant of that decision.
2. The Board will consider the circumstances and the request of the member for financial assistance. The financial assistance may not exceed \$2000. The final awarded amount will be determined by the Texas State Council BOD.
3. Approved funds will be distributed by the treasurer in the form of a check or other approved electronic form of payment to the Texas State Council member.
4. A form 1099 will be issued to any recipient of financial assistance in accordance with IRS rules.
5. The circumstance and amount of any assistance provided to a Texas State Council member will be entered into the minutes at the next BOD meeting and reported at the next quarterly meeting of the Texas State Council General Assembly.
6. The Treasurer will report changes in revenue and expenses in the Ansley fund to the Texas State Council General Assembly quarterly.

Donations to the Ansley Fund should be made payable to Texas ENA: attention treasurer and recorded as a donation to the Ansley Fund for accounting purposes.
